Call for Proposal

Catalyzing Just Energy Transition through CSO Coalition in Jambi

1) BACKGROUND

The “Enabling Civil Society's contribution to Prosperous, Fair and Sustainable Development in Energy Transition and Sustainable Land Use” Project aims to mainstream and strengthen civil society organizations (CSOs) at both national and sub-national levels. This will enable them to play a significant role in shaping energy transition and sustainable land use policies along with monitoring their implementation at field level.

The proposed initiative unites WWF Indonesia and AURIGA, two organizations with extensive experience, grounded in lessons learned from policy work related to energy transition and land use management, while collaborating closely with other CSOs across various levels.

To ensure credible participation and advocacy, CSOs must deliver data-driven, evidence-based approaches. This should be achieved through a robust CSO network, complemented by science-backed solutions based on reliable data and information. Additionally, public engagement must be intelligent and responsible, utilizing social media effectively to mobilize a wide and diverse constituency.

The Financial Support to Third Parties (FSTP) aims to empower civil society organizations (CSOs) to play a key role in advancing the just energy transition in Indonesia. Through this program, CSOs will contribute to achieving the following targets:

1. Strengthening multi-stakeholder forum for achieving GHG emission reductions through a fair and equitable energy transition, ensuring that all voices are heard and that the needs of vulnerable communities are prioritized.
2. Creating and promoting comprehensive policy briefs that outline actionable strategies for a just energy transition, ensuring that policies address social equity, economic inclusivity, and environmental sustainability.

In order to achieve the two targets mentioned above, the program "Catalyzing Energy Transition through CSO Coalition in Jambi" will support the CSO to undertake the following activities:

- Building the capacity of CSOs in energy transition-related areas, including technical expertise, policy advocacy, and community engagement.
- Establishing and consolidating networks with energy transition stakeholders at the regional level to foster collaboration and knowledge sharing.
- Supporting CSOs coalition to effectively engage in policy advocacy and dialogue in energy transition policies
- Delivering science-based policy briefs, developed by the CSO forum, to relevant policymakers.
- Delivering science-based briefs developed by CSO forum to relevant policymakers

Through these efforts, we expect CSOs to play a crucial role in advancing a just energy transition in Indonesia, particularly in Jambi. By empowering CSOs to actively participate in these activities, the FSTP aims to contribute to a more just, inclusive, and resilient energy transition.

2) General Requirements for FSTP

This FSTP program is specifically focused on addressing energy transition issues at the provincial level. CSO applicants must be based in Jambi province, one of WWF Indonesia's priority working areas. In addition, applicants must meet the following requirements:

- 1) Must have legal status in Indonesia.
- 2) Must be a Civil Society Organization, such as a Non-Governmental Organization (NGO) or Community-Based Organization (CBO).
- 3) Must not be affiliated with any political interests.
- 4) Must demonstrate strong institutional governance, including transparent financial management.
- 5) Relevant experience in energy transition, climate change, or related environmental issues is preferred.
- 6) Established relationships or networks with relevant stakeholders are preferred.

3) Proposal Assessment

In addition to the above requirements, WWF-Indonesia will also assess applicants based on the following criteria:

- a. Experience in the dynamics of multi-stakeholder forum.

- b. Experience in collaborating with government at both local and national levels.
- c. Experience in managing grant funds.
- d. Capacity to map relevant stakeholders.
- e. Knowledge of energy transition, climate change, or related environmental issues.

WWF-Indonesia will announce the grant recipients, who will receive funding for a 24-month period, with a maximum amount of IDR 835,000,000. The funding period will run from November 2024 to November 2026.

The Call for Proposal will follow these stages:

1. WWF-Indonesia announces the open call for proposals through its website.
2. Prospective organizations submit proposals based on the specified criteria.
3. WWF-Indonesia reviews the proposals and invites shortlisted candidates for discussions.
4. Announcement of subgrant recipients and preparation of contracts.

4) TIMELINE OF GRANT FUNDING PROPOSALS AND CONTRACTS

- 23 October 2024: Deadline for submission of narrative proposal and requested budget by prospective partners.
- 24–31 October 2024: Discussions with shortlisted candidates for clarification of narrative proposal and the due diligence process.
- 8 November 2024: Announcement of the selected partner.
- 11–15 November 2024: Grant contract signing with partner.
- 18– 26 November 2024: Disbursement of initial funds and commencement project implementation.
